Regulations for Bushy Park Show- Saturday 16th February 2019

Please read all information carefully. All pages contained herein constitute the terms and conditions for ground space applications. Ignorance of these conditions will not be accepted as a reason for failure to comply. If you have any questions regarding ground space, please do not hesitate to contact either the Secretary on the above number or the Site Co-Ordinator via email: bushyparkshow@hotmail.com.

Terms & Conditions

1. Applications must be received by the **due date (Friday 1st Feb, 2019)**.
Early return of forms guarantees your application has enough time to be processed by the Society. **Late applications may or may not be accepted/may incur an additional fee.**
2. If you require a powered site, this must be indicated on the application form.
3. **Any vehicle required as part of your site must be included in your booked space. All other vehicles once unloaded are to be parked ONLY in the places specifically advised for site holder vehicles.**
4. **All fees must be paid prior to Show Day.** Site is not guaranteed until full payment has been received and receipted. Attach copy of your Insurance (Cert of Currency). Advise us if you do not have this.
5. In the event of cancellation on your part or failure to attend, site fees will be non-refundable.
6. Sites are allocated on a first-come basis, with priority being given to Show Sponsors where this is part of their sponsorship package. Decisions on site allocation are final and no discussion will be entered into.
7. Instructions from Bushy Park Show Society Committee members must be followed at all times.
8. The Bushy Park Show Society reserves the right to refuse entry or to ask any exhibitor to leave the Showground if they fail to heed instructions from any member of the Committee.
9. Any authorised member of the Committee or our appointee has the right to enter a Stall Holder's Site and remove any material that may be considered offensive to the public, exhibitors or the Society.
10. **All sites to be occupied by 8-30am on Show Day and all site owners are asked not to begin packing up prior to 4-00pm. *Strictly no vehicle movement prior to 4pm.***
11. All power users must supply their own Residual Current Interrupter (surge protector) to be connected at their site and ensure all electrical items are appropriately tagged. Cords in a public traffic area must be covered by a heavy mat for safety purposes.
12. In the event of an excessive number of applications from like vendors the committee reserves the right to limit the number accepted. This is in the interest of both the committee and the vendors. A decision will be given as soon as possible after application has been received.
13. The Bushy Park Show Society Committee reserve the right to run their own raffle for fundraising and advise that all raffles and sports-card sales etc. need committee approval.
14. It is responsibility of siteholders to erect their gazebo to standards ensuring they are secure. Please ensure all tie ropes onto tent pegs are marked at couple places along the rope with fluro tape to alert the public and avoid trip hazards.
15. Exhibitors must comply with all current Government Regulations **Smoke Free Event.**
